- Monsanto problem with the core business, not just policies/behavior, it would make more sense to just screen it out. Move to add Monsanto to the DNB list, Glenn moved and David seconds, approved unanimously
- o Rubbermaid will look at it in 6 months
- Dow Brennan moves that we add Dow to the DNB list, Billenness seconds, approved unanimously
- O Tyson the issue here is behavior, will look at this in 6 months
