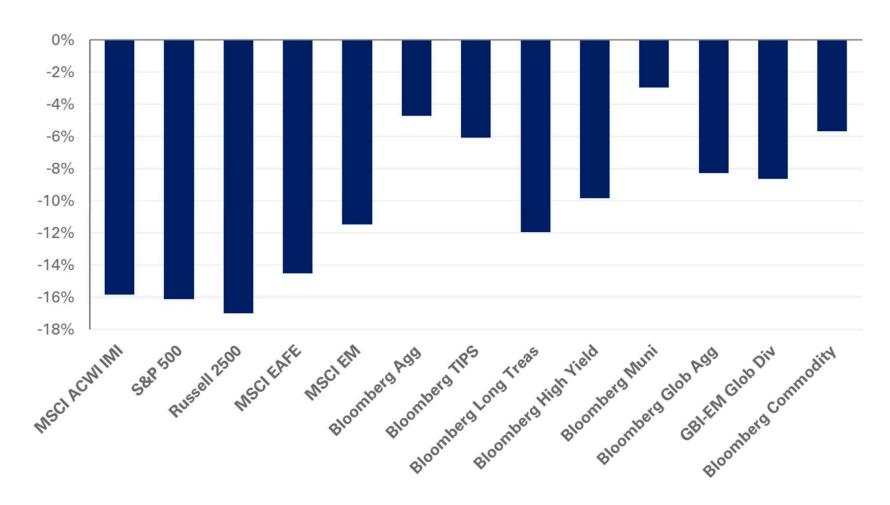

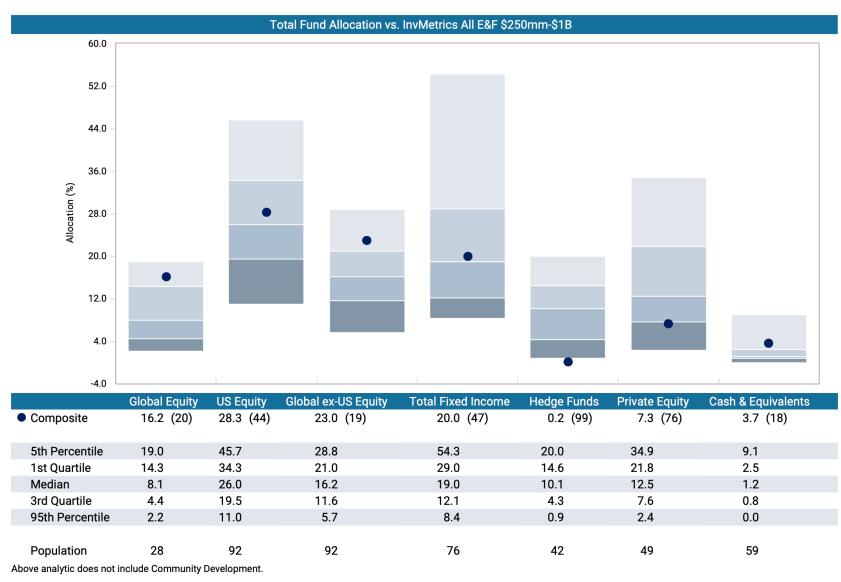
- The Endowment returned -11.4% (gross of fees) during the second quarter 2022, ranking in the 82nd percentile of the universe, underperforming the allocation index
 - Active management detracted 40 bps for the quarter due to large cap equity, emerging market equity and flexible fixed income manager underperformance
- Allocation differences compared to policy targets added 60 basis points of value during the quarter (Policy Index vs. Allocation Index)
 - o The Plan's underweight to equity and overweight to cash during the quarter was a relative positive
- Longer-term, the Endowment performance ranked in the bottom half relative to peers as the 2021 & 2022 results have weighed on longer-term returns

- Approved two new private equity managers:
 - \$2 million to MPowered Capital Access Fund
 - \$2 million to Wellington Access Ventures Fund
- Discussion of engagement priorities for 2023
 - Will continue 2022 priorities into 2023
 - Strategic discussion around where we wish to focus engagement; related to process of SRI guideline revisions
- Reviewed results of NEPC-led survey of Investment Committee members, with an eye toward aligning next round of Investment Policy Statement (IPS) edits around consensus positions.

SRI UPDATES

- Maximum CU200 position of \$100k was implemented
 - However, the equity sales happened with 7-1-22 settlement dates, so this
 does not appear yet on our 6-30-22 Holdings Report
- SRI Guidelines Revision Team to begin soon!
 - Open meeting on Thursday, 10-6-22, 7pm 8:30pm ET

UUCEF STATEMENT CHANGES eff. 7-31-22

- Conversion from GL-based approach to Net Asset Value (NAV) centered process
- Under old system, statements reflected a pro rata allocation of all UUCEF transactions
 - Some of this provided valuable detail: fees, investment income
 - Some was confusing: realized/unrealized gains/losses
- New statement format should streamline month-end entries for investors and will accurately capture realized gains/losses from congregation's perspective.

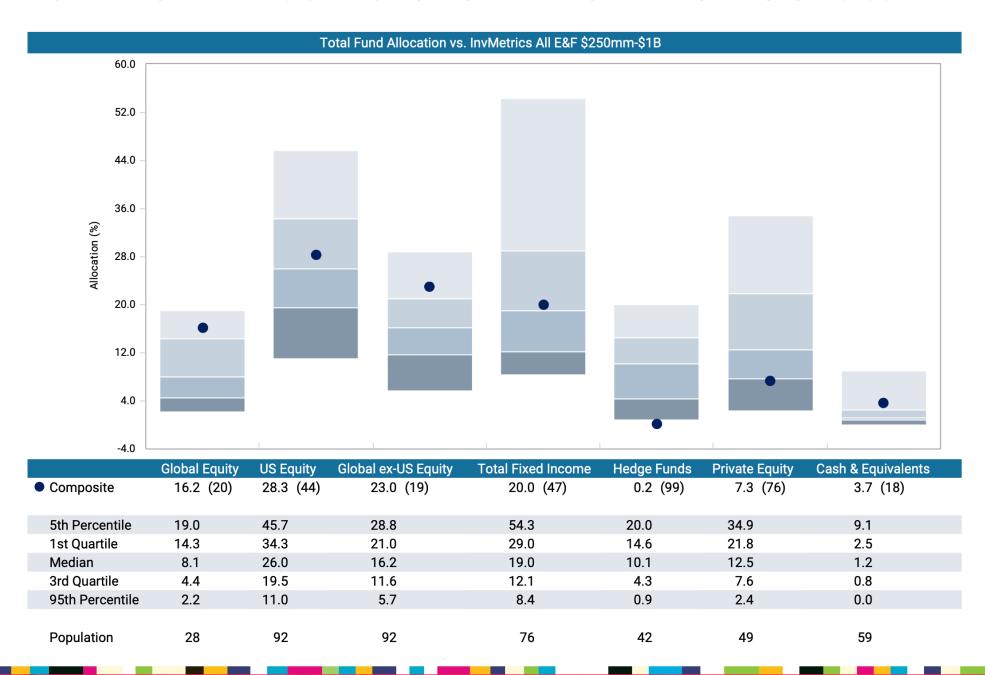

Asset Allocation Targets, eff. 11-3-21

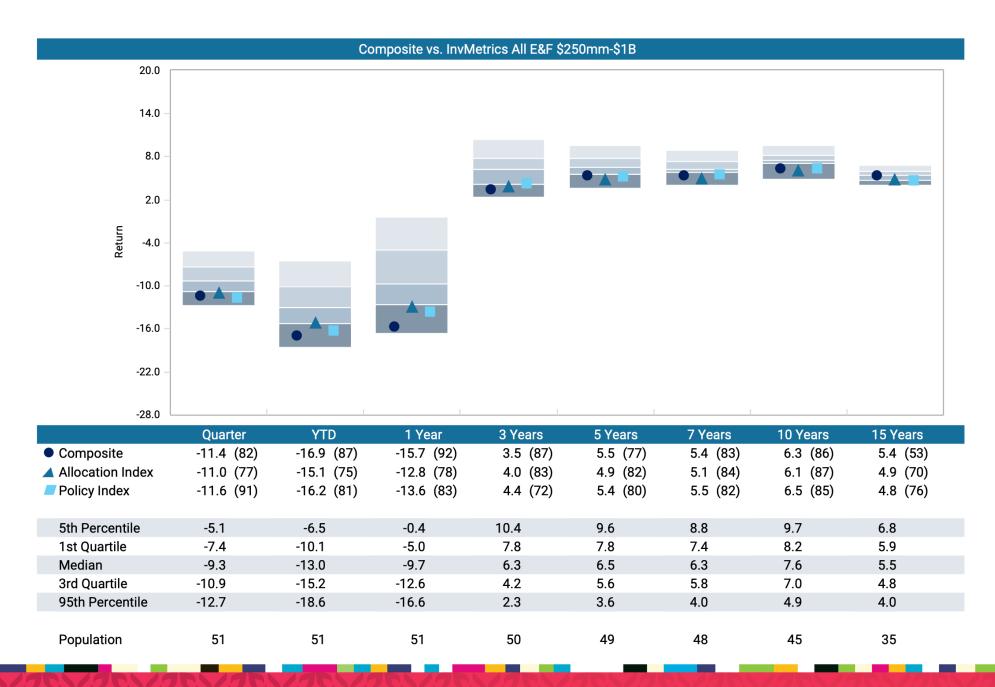

SRI – Socially Responsible Investing

 Socially responsible investing, or SRI, is ensuring that our investments are aligned with our values. For more information on the UUA's approach to SRI, see: http://uucef.org/socially-responsible-investing/about-sri/.

ESG - Environmental, Social, Governance

 Incorporating ESG factors into the investment process takes investors beyond purely financial analysis and provides added insight into the quality of a company's management, culture, risk profile and other characteristics. For further details, you can review ESG definitions here:

Glossary:

UN PRI – United Nation Principles for Responsible Investment

- The PRI is the world's leading proponent of responsible investment. It supports its international network of investor signatories, now with \$59 trillion in assets, in incorporating ESG factors into their investment and ownership decisions. For more information see: https://www.unpri.org/about
- **Benchmark** For each asset class, the appropriate index return against which a particular strategy can be evaluated. For example, a benchmark for large US companies is the S&P 500.
- Allocation Index The average benchmark return for all of the asset classes in the portfolio weighted according to the actual weights of the assets in the portfolio at a given time. This measures the effect of actual allocation decisions.
 - = ACTUAL ASSET WEIGHTS X INDEX RETURNS

Glossary:

- Policy Index The average of the benchmark returns for all of the asset classes in the portfolio weighted according to the *target* weights of the assets in the portfolio at a given time. Measures policy allocation decisions.
 - = TARGET ASSET WEIGHTS X INDEX RETURNS
- Composite Return The total, blended return for the portfolio.
 Measures actual performance.
 - = ACTUAL ASSET WEIGHTS X ACTUAL RETURNS
